TERMS AND CONDITIONS OF AGREEMENT TO PROVIDE FOSTER CARE

1. The Foster Home agrees they are responsible for all NON AUTHORIZED veterinary medicine and other costs associated with the animal while the animal is in their care, and that have not received and that when the animal is returned to West Coast Animal Rescue Society ("WCARS"), WCARS will not be responsible to repay such costs.
2. The Foster Home agrees to abide by the regulations of the Animal Control Bylaws in their community.
3. The Foster Home hereby agrees to release and discharge WCARS, its directors, employees and agents, of and from any claim, damage, suit, cause of action, demand or expense whatsoever which the foster home, his or her heirs, executors, administrators or assigns can or may have in relation to any loss, cost, damage, or injury that they may sustain or suffer arising out of the fostering of animals.

4. The Foster Home hereby agrees to indemnify and save harmless WCARS, its directors, employees and agents, from and against any and all claims, causes of actions, suits or demands whatsoever that anyone might have as a result of the fostering described herein and any loss, costs, damage or injury sustained or suffered by any one in relation thereto.
5. The animal being fostered will be returned to WCARS on demand or may be returned by the person fostering at any time.
6. Loss of, or injury to the animal, shall be reported to WCARS directors immediately.
7. No animal will be taken into foster care on behalf of WCARS without express consent of the coordinator.
8. WCARS and the Foster Home will make every reasonable effort to find a suitable adoptive home for the animal in foster care.
9. The Foster Home agrees to allow potential adoptive people reasonable access to their property to meet the animal being fostered.
10. No animal shall be released without proof of adoption or written or verbal consent from a WCARS director.
11. The Foster Home agrees to notify WCARS immediately of any births when fostering pregnant animals.
12. The Foster Home herein consents to allow any announced or unannounced inspections of the animal in my care and upon my property by WCARS and, herein give express permission to WCARS to enter upon my property for the purpose of such inspections.
13. WCARS reserves the right to terminate this agreement without notice. Should this happen, WCARS will take the animal being fostered back into care.
14. This agreement comes into effect on: _____ 20___, and shall remain in effect until such time that:
 - a) the animal is adopted, or,
 - b) the animal is humanely destroyed by WCARS; or,
 - c) WCARS removes the animal being fostered from my home; or,
 - d) WCARS terminates this agreement.
15. As part of this agreement I pledge to provide care as follows:
 - a) to provide foster care for the animal to the best of my ability,
 - b) to provide daily: food, water, shelter, care, and exercise to the foster animal in my care

- c) I will not abuse or neglect the animal in my care in any way
- d) I will contact WCARS immediately if veterinary services are required by the animal in my care
- e) I understand WCARS will not assume any liability for any person property damage at my home, which may be caused by the animal(s) in my care.

I am over the age of 19 and I have read and fully understand the terms and conditions of this agreement, and agree that it is not arbitrary and that provisions herein are common in pet foster care agreements. I further understand that if I fail to comply with any of the terms specified herein, WCARS has the right to reclaim the animal, and to enforce this contract in a court of law.
